# **Investment Strategy**

The DJE - Gold & Ressourcen is a thematic global equity fund. The concentrated portfolio of 50-70 stocks focuses on companies in the mining, processing and marketing of gold. Equities from the broader commodities universe, such as diversified mining companies, non-ferrous metals, oil and gas, can also be added for further diversification. The investment strategy is completely independent from any benchmark requirements and the share of gold mining stocks can vary between 30 and 100%. With gold as the investment focus, the fund offers diversification and a lower correlation to traditional investment strategies.






# **Currency Exposure (% NAV)**

#### **Investment Approach**

The thematic and globally investing equity fund focuses on gold and precious metals, diversified commodity groups, base metal producers, chemical companies and oil & gas producers. The fund pursues a bottom-up approach with high-quality stock selection, focusing on the fundamental key financial indicators of the companies. We invest primarily in gold producers with a competitive cost structure that generate free cash flows even at lower gold prices. In general, negative or falling real interest rates are positive for tangible assets, particularly gold. Demand for gold is likely to rise if real interest rates are low or fall.

#### **Monthly Commentary**

The DJE - Gold & Ressourcen rose by 0.42% in May. The XAU gold mining index rose by 8.94% in US dollar terms and by 7.26% in euro terms due to the depreciating US dollar. Gold mining shares thus outperformed the gold price itself, which rose by 1.80% in USD terms to 2,327.33 per troy ounce. In euro terms, the troy ounce rose by 0.13% to 2,147.48 euros. Towards the middle of the month, the price of gold had reached a record high of USD 2,450 per troy ounce as hopes of an interest rate cut in the USA strengthened on the back of lower inflation data. However, gold subsequently gave back some of its gains when stronger-than-expected US economic data and hawkish comments from the US Federal Reserve argued against interest rate cuts. The published minutes of the Federal Open Market Committee (FOMC) indicated that the current higher interest rates of 5.25% to 5.50% could be maintained for longer than expected. As a result, market expectations for the first interest rate cut were postponed by 25 basis points until December. Gold was greatly supported by central banks' gold purchases, which also increased in the first quarter of 2024. Further support for the gold price came from China: Chinese households have also been buying more gold again for some time, primarily as protection against a possible further devaluation of the Chinese currency. The highest positive performance contributions in May came from the positions of the two gold mining companies Kinross Gold and Agnico Eagle Mines as well as the uranium producer Cameco - all three companies from Canada. In contrast, the performance was negatively impacted by the positions in the German-American industrial gases manufacturer Linde, the British mining company Anglo American and the South African gold mining company Gold Fields, among others. The weighting of gold mining stocks was over 51% in the reporting period, which corresponds to an increase compared to the previous month (over 49%). The focus remains on solidly financed producers that generate positive free cash flows even at lower gold prices and also have some growth prospects. Broad-based commodity/chemical stocks generally underperformed gold mining stocks in May: the MSCI World Materials index rose by +1.48% and the CRB commodity index fell by -1.99% - both index figures in euro terms.
